

COOPERATION AGREEMENT
Signed in 2018

between

Jan Amos Komenski State School of Higher Education in Leszno (Poland)

And

Northern University in Yerevan (Armenia)

§ 1

The main purpose of this Agreement is to expand relations in the field of education in the spheres of humanities, social, economic sciences, tourism and scientific research.

§ 2

The Parties responsible for performing the tasks set out in the Agreement:

1. From the side of Northern University - **Rector Boris Makichyan**
2. From the side of Jan Amos Komenski State School of Higher Education in Leszno - **Rector, Prof. Maciej Pietrzak**

§ 3

The main directions of the cooperation

1. In the field of research: The exchange of scientific information and research results, organization of joint conferences and symposia with the participation of the other Party representatives.
2. In the field of education: student exchanges, academic staff exchanges, familiarization with educational work in order to increase integration.
3. In the field of publishing activities: preparation and publication of joint scientific, research and other works.

§ 4

- The agreement will be implemented in the form of:
- personal exchanges, including scientific internships
- organization of scientific seminars, conferences, symposia,
- conducting joint research
- exchange of scientific information

§ 5

The Parties agree on the following financing terms:

1. The sending Party covers the cost of travel till the destination, the receiving party covers the costs relative with the stay in case of official visits up to two weeks. The conditions for longer visits and university staff and student mobility will be discussed by both parties in written form..

2. All persons traveling in the framework of this Agreement receive the same rights that employees and students of the host institution have, within the laws and statutes, with the exception of medical insurance. Travelers must independently collect the appropriate documents, insurance against illness and the consequences caused by natural disasters.
3. Scientific research will be funded under conditions agreed by the parties for each case.
4. The development and transfer of materials for research implementation, the Parties agree individually for each case.

§ 6

The Cooperation will be held taking into account the interests of each Parties in the protection of intellectual property, namely:

- protection of patent and intellectual property rights,
- protection against unfair competition
- preservation of secrets

§ 7

1. This Agreement will enter into force since the signing.
2. Each Party has the right to terminate this Agreement with a notice of three months.
3. Amendments to this Agreement may be made in the form of annexes signed by both Parties.
4. The contract is made in 4 copies (each Polish, Russian, Armenian and English) - one copy for each of the Parties. All the versions are identical and have the same legal force.
